



# Work Safety Alert Struck by an Excavator

1. Date of Accident: May 2014

**2.** Place of Accident : A foundation site

## 3. Summary:

A welder was struck to death by the slewing boom of an excavator when he was working in its vicinity.

## 4. Work Safety Alert for Contractors/Employers:

To prevent worker from being struck by mobile plant, contractors/employers should:

- appoint a competent person to conduct task-specific risk assessments paying special attention to any interfaces between the operation of the excavator and work activities nearby where workers engaged in such work activities may be endangered by any movement of the excavator;
- develop and maintain an effective safe system of work in respect of the mobile plant operation and the work activities to be performed nearby;
- properly segregate and impose strict access control to the area within which the mobile plant may operate or move to ensure that workers are not allowed to enter the operation zone unless steps have been taken to assure a dead stop of the mobile plant;
- assign suitable person(s) to administer the access control system and effectively communicate the striking hazard of the mobile plant by, e.g. posting suitable warning notices at conspicuous positions;





- station a signaler to give effective signals to the plant operator who does not have a clear and unrestricted view within the operation zone of the plant;
- install suitable safety devices on the mobile plant, such as closed-circuit televisions to enhance the operator's views (especially the rear view and other blind spots) and equip the plant with audio/visual alarms to alert persons working nearby for any of its reversing or swinging motion;
- ensure that every worker who is permitted to enter the operation zone of the plant is wearing a high visibility or reflective vest;
- provide relevant safety training, information, instruction and supervision to the involved personnel such as the plant operator, the signaler, and person(s) administering the access control as well as workers concerned;
- ensure the plant is properly maintained and in a safe working condition; and
- implement an effective monitoring and control system to ensure strict compliance with all the above safety measures and precautions.
