**Occupational Safety & Health Visit to Ping An International Finance Centre and China Vanke Co.'s Construction Site (公園里) at Shenzhen on 5 January 2015 (Monday)**

**Objective:** To appreciate and learn the good practices of occupational safety and health management of two construction sites in Shenzhen: Ping An International Finance Centre and China Vanke Co.'s Construction Site (公園里).

Ping An International Finance Centre is a 115-story megatall skyscraper of 660 meter high, expected to be completed in 2016; and will at that time be the 2nd or 3rd tallest building in the world, as well as the tallest in China.

China Vanke Co. is the largest residential developer in China, whose business covers 53 large and medium-sized cities in the Pearl River Delta region, the Yangtze River Delta region and the Bohai Economic Rim, as well as central and western parts of China. 公園里 is a residential project in Longgang area (龍崗區). Elevated working platform attached to the building wall was used to reduce the risk of person fall from height.
