Mr. KU is a retired commercial diver (1979 to 2006). He possesses experience and knowledge for a variety of commercial diving operations including inshore, offshore, high altitude, maritime, rescue, salvage, underwater film shooting, underwater blasting, high pressure environment (except Potable Water Tank, Nuclear Diving [heavy water (nuclear power)], [Ice Dive] operations).

He was also a commercial diving auditor (2006 to 2016) and was appointed by ADCI (Association of Diving Contractors International) as one of the Southeast Asian auditors to carry out audit in Southeast Asia.



Abstract :

The seminar aims to provide professional knowledge, safety operations and practical knowledge of diving equipment for commercial diving personnel. It is expected that commercial diving personnel could enhance the application of diving and technology in different types of work to ensure a safe and healthy working environment.
