#### Speaker:

Mr Yu Shuxi was the first director of Guangzhou Administration of Work Safety and the counselor of the People's Government of Guangzhou Municipality. He was the founding president of Guangzhou Association of Work Safety. At present he is a legislative consultative expert of Guangzhou Municipal People Congress, an arbitrator of Guangzhou Arbitration Commission, a retired IOSH Honorary Vice-President, an IOSH Honorary Fellow, the chief expert of Guangzhou Association of Work Safety.

Mr Yu Shuxi has been engaged in policies, regulations and administrative law enforcement for government for a long time. He conducted a great deal of legal and policy research and decision-making work for the government's economic reform, administrative law enforcement and administrative litigation and successfully handled many important economic and administrative legal disputes and important work safety accident problems.

He successfully organized the drafting of local laws and regulations "the Guangzhou Work Safety Regulations", participated in the drafting of Guangzhou and Guangdong Province local standards of work safety, "The Air Conditioners High-altitude Operating Safety Norms" and the Guangzhou local standards "Management Norms of Work Safety Standardization for commercial and trade enterprises". He was also invited by Standing Committee of Guangdong Provincial People's Congress to participate in the revision and demonstration work on "Guangdong Province Work Safety Regulations" and was widely praised. He was twice appraised jointly by the Propaganda Department of the Central Committee of the Communist Party of China and the Ministry of Justice as a "National Advanced Worker of Law Publicity" and was awarded as an "National Excellent Individual of Work Safety Administration" by the State Administration of Work Safety.
