



Work Safety Alert Use of Portable Ladders

1. Date of Accident: December 2011

2. Place of Accident: A shop in Tin Shui Wai

3. Summary:

It is reported that a worker fell a distance of about 1.5 metre from a wooden stepladder while conducting false ceiling installation work and subsequently passed away.

4. Work Safety Alert for Contractors/Employers:

Contractors/employers undertaking building repair/maintenance works should -

- avoid work at height where possible;
- consider using portable ladders only if other alternatives, such as scaffolding or elevated working platforms, are not reasonably practicable;
- ensure the use of portable ladders is restricted to light-duty work that is performed for short periods of time; and
- provide workers with proper training and instructions on the safe use of portable ladders.

Work Safety Alert Tree Work

1. Date of Accident: January 2012

2. Place of Accident: A slope in Sha Tin

3. Summary:

It is reported that a worker fell a distance of about 9 metres to his death while pruning a tree with a portable chainsaw.

4. Work Safety Alert for Contractors/Employers:

Contractors/employers undertaking tree work should -

- appoint a competent person to conduct risk assessments and formulate appropriate safe working methods for the tree work;
- avoid work at height wherever possible;
- where work at height is necessary, use elevating work platforms or suitable scaffolds as safe means of access and support for the work so far as reasonably practicable; and
- provide workers with proper training and instructions on the safe use of chainsaws.

3. Summary:

It is reported that a worker fell a distance of about 2 metres while climbing up a metal stepladder to repair a sewage pipe and subsequently passed away.

4. Work Safety Alert for Contractors/Employers:

Contractors/employers undertaking building repair/maintenance works should -

- avoid work at height where possible;
- consider using portable ladders only if other alternatives, such as scaffolding or elevated working platforms, are not reasonably practicable;
- ensure the use of portable ladders is restricted to light duty work that is performed for short periods of time; and
- provide workers with proper training and instructions on the safe use of portable ladders.
